Hauv Paus Tsev Kawm Ntawv Fresno zoo siab tshaj tawm tias peb yuav pib siv qhov Raptor Visitor Management System nyob rau hauv peb cov tsev kawm ntawv nrog rau hauv paus tsev kawm ntawv qhov kev npaj rau kev kaj huv twb muaj yav tag los lawm. Qhov uas ua tau rau peb cov tub ntshais kawm thiab neeg ua hauj lwm nyob kaj huv yog paub hais tias leej tws tuaj rau hauv peb cov tsev kawm ntawv- yog li ntawm qhov Raptor system no yuav cia peb paub li ntawm. Qhov Raptor system yuav cia peb paub txog cov neeg tuaj saib, neeg ntiav tuaj ua hauj lwm, thiab cov neeg tuaj pab hauv peb cov tsev kawm ntawv thiab cia muaj kev kaj huv rau peb cov tub ntshais kawm thiab neeg ua haujlwm. Cov neeg ua haujlwm hauv tsev kawm ntawv mus rau lwm lub tsev kawm ntawv los yeej yuav tau ua ib tib yam.

Thaum yuav tuaj nkag rau hauv ib lub tsev kawm ntawv, yuav tsum tau nug cov qhua kom lawv muab lawv daim ID hauv lub xeev coj los muab txhuan (tsom) ntawm qhov Raptor system. Qhov Raptor system yuav tshuaj saib daim I.D. ntawm puas muaj npe nyob rau hauv lub teb chaws txog kev quab yuam ua niam txiv. Yog hais tias tus qhua ntawm daim I.D. muaj cov ntaub ntawv li ntawm nyob hauv lub teb chaws ces yuav tau muab tus qhua ntawm tshem tawm hauv tsev kawm ntawv mus. **Nws yog ib qhov tseem ceeb hais tias qhov Raptor system tsuas yog saib tug qhua ntawm lub npe, hnub yug, thiab daim duab xwb.** Hais qhia ntxiv tias yuav tsis muab lwm cov ntaub ntawv nyob rau hauv daim ntawv tsav tshab los sis yog yuav tsis muaj kev txuas mus rau ntawm lub Department of Motor Vehicles. Yog li ntawm lwm cov ntaub ntawv nyob ntawm daim ID yuav tsis muab tsom saib los ntawm qhov kev ntsuas no thiab yuav tsis muab rau lwm tus siv. Thaum muab tsom tag tau kev tso cai lawm, qhov Raptor yuav luam ib daim ntawv qhia txog tus qhua zoo li muaj hnub thiab nws tuaj saib tsev kawm ntawv ua dabtsi.

Daim ntawv sau npe no yuav tsis cia kom cov neeg coj khoom tuaj losyog tuaj nqa khoom ua. Yog thaum qhia tsis tau tus neeg ntawm lawm ces nws yuav tau sau nws lub npe thiab hnub yug zoo li hais sau no ces qhov kev tsom ntawm yuav luam ib daim ntawv tuaj ua qhua rau nws. Yog hais tias tau kev tso cai (losyog kev tsom tsis muaj dabtsi) ces tus neeg ntawm yuav tau kev tso cai mus rau hauv tsev kawm ntawv thiab yuav tau txais ib daim ntawv tuaj ua qhua thiab yuav muaj ib tus neeg coj kev.
